Another Kind of Normal

Detailed analyses of the moral, religious and scientific underpinnings of the text enable a new interpretation that is rooted in the project's core philosophy, yielding more knowledge about *The Revaluation of All Values* as well as Nietzsche's last philosophical thought and position.
